AMHC provides integrated healthcare services that empower individuals to recover and enhance their overall quality of life. Services are available in Aroostook, Hancock, and Washington counties and can be accessed by calling the AMHC Call Center at 1-800-244-6431. Most insurances are accepted, and a sliding fee schedule based on family size and income is available. No one is denied services due to an inability to pay, and several programs offer free services.

## **MENTAL HEALTH**

AMHC offers mental health treatment and recovery-focused services for adults, children, and families. Service starts with an assessment to understand an individual's concerns and treatment needs.

### **Mental Health Outpatient**

A variety of adult and children's services in Fort Kent, Madawaska, Caribou, Presque Isle, Houlton, Calais, Machias, and Ellsworth including outpatient therapy, co-occurring mental health and substance use services, couples & family therapy, medication management, Employee and Student Assistance Programs (EAP)/(SAP) and school based mental health therapy services.

### **Psychological Testing Services**

Psychological services are offered in the community primarily in a school setting or AMHC outpatient office. Testing for veterans is available at Veterans Administration in Caribou.

### **Adult and Children's Behavioral Health Home (BHH)**

A holistic case management service for adults and children challenged with behavioral, physical, and emotional needs. Services offered at outpatient offices, a client's home, or community setting, school, etc.

### **Community Integration**

Case management service provides a variety of skill and resource-focused interventions to achieve and maintain independent daily living, fostering self-determination to develop specific goals based on needs and wants in the areas of housing, financial stability, meaningful activities, employment as well as relationships and social interaction with family/natural supports and community members. Services are offered in an individual's home, community, or AMHC outpatient office.



### **Community Care Teams (CCT)**

Available in Hancock and Washington counties. Support for individuals with chronic health conditions with help to follow doctor's orders, manage health, and care for oneself comfortably at home. CCT also offers advocacy, caregiver support, and referrals for various health, education, social, mental health, and substance use services.

### **Children's & Adult Residential**

Each facility is staffed 24/7 and includes treatment in a structured environment to support individuals with behavioral health challenges. CARF Accredited.

- Located in Calais, Children's Residential is a 10-bed facility that supports children ages 7-19 who are facing behavioral and developmental challenges. CARF Accredited.
- Located in Madawaska (Madawaska Group Home) and Presque Isle (Skyhaven), adult residential homes offer residents the opportunity to learn independent living skills in a community setting.

### **County Ride**

Available in Aroostook County. Transportation services for adults 18 and older with serious mental illness who meet the specific eligibility requirements for Section 17, Community Integration Services. The service can be reached at 207-492-1379.

### **Supportive Housing**

Available in Aroostook County. Offers stable, affordable housing to individuals who meet MaineCare Section 17 criteria, and voucher programs like Bridging Rental Assistance Program (BRAP) and Shelter Care. ### **Mental Health Support Centers**

Available in Aroostook County. All services are free of charge. Two peer-led mental health support centers provide persons 18 and older with mental health challenges the opportunity to experience peer-to-peer support services in empowering ways. ## **SUBSTANCE USE**

Substance use disorder is a disease that creates significant health issues and impairs one's ability to meet responsibilities at work, school, or home due to recurrent alcohol or drug use. It often coincides with other mental health, or co-occurring conditions. AMHC offers treatment and recovery services for individuals, families, and affected others.

### **OPTIONS**

OPTIONS (Overdose Prevention through Intensive Outreach, Naloxone & Safety) liaisons focus on overdose prevention and help community members get connected to substance use treatment & recovery services. ### **Substance Use Outpatient**

Services are provided in Fort Kent, Madawaska, Caribou, Presque Isle, Houlton, Calais, Machias, and Ellsworth including individual and group counseling, intensive outpatient (IOP),

co-occurring substance use and mental health treatment, medication for opioid use disorder (MOUD)/medicated assisted management (MAT), Opioid Health Home (OHH), and Driver Education and Evaluation Program (DEEP). A focus on holistic support, integrating treatment, counseling, and care management for substance use and related issues.

### **Downeast Treatment Center (DTC)**

Available in Hancock County. Located at 70 Kingsland Crossing, Ellsworth, DTC merges outpatient services for improved accessibility. Operating on a “hub and spoke” model, it collaborates closely with primary care providers, offering ongoing Medication Assisted Treatment (MAT) and robust recovery support.

### **Residential Treatment Facility (RTF)**

Statewide referrals accepted. AMHC’s Residential Treatment Facility (RTF) is an 18-bed facility. Located at 176 Academy Street in Presque Isle, it is an intensive, structured care facility offering 28-day/24/7 treatment. The program involves daily individual and group therapy, family treatment, weekly coordination meetings with community providers, and skill-building activities crucial for daily recovery. ### **Treatment and Recovery Court**

Criminogenic treatment services available in Hancock and Washington counties. AMHC provides substance use and co-occurring mental health treatment services for Washington and Hancock County treatment and recovery courts.

### **Substance Use Recovery Support Centers**

Available in Aroostook and Washington counties. All services free of charge. Centers are staffed by individuals who are in long-term recovery and now assist others facing similar circumstances. They help individuals become and stay engaged in the recovery process, thereby helping to reduce the likelihood of reoccurrence or return to use. The services are available at Roads to Recovery (Caribou), Aroostook Recovery Center of Hope (ARCH) (Houlton), and Downeast Recovery Support Centers (Calais and Machias).

## **CRISIS SERVICES**

AMHC offers 24/7 crisis services, available at home, in the community, and through telehealth. Additionally, during business hours from 8 a.m. to 5 p.m., crisis services are accessible at any AMHC outpatient office in Fort Kent, Madawaska, Caribou, Presque Isle, Houlton, Calais, Machias, and Ellsworth. These services encompass mental health and substance use assessments, safety planning, and necessary referrals for further support.

### **Mobile Crisis Line**

Mobile crisis intervention is available 24/7, 365 by calling 1-888-568-1112 or 988.

### **Mobile Crisis Response**

Providers meet with individuals in their home or other community setting to provide crisis assessments and establish levels of care and safety plans and appropriate interventions.

### **Crisis Stabilization**

For those who need ongoing support after an initial crisis assessment to remain in the community. Mobile Crisis Services providers offer crisis follow-up care for sixty days (as long as it is clinically indicated).

### **Crisis Stabilization Units (CSU)**

Statewide referrals accepted. Secure and supportive 24/7 short-term residential environment offering support, crisis intervention, safety planning, and service referrals for individuals stabilizing from behavioral health crises. Anyone can make a referral by directly contacting the unit.

Adult CSU: Presque Isle at 1-800-432-7805; and Calais at 207-454-1910.

Children’s CSU: Fort Fairfield at 207-473-9285; and Calais at 207-454-0322.

### **Critical Incident Stress Debriefing (CISD)**

Support for individuals or groups affected by community or workplace trauma like suicide, violence, or natural disasters. Ideally, CISD takes place within 24 to 72 hours post-incident and can be accessed by calling the AMHC Call Center at 1-800-244-6431.



## **SEXUAL ASSAULT SERVICES**

All services are free of charge. AMHC Sexual Assault Services operates 24/7, extending confidential support to those impacted by sexual assault by promoting healing and justice through advocacy, education, and prevention efforts. ### **Advocacy and Prevention**

Comprehensive advocacy services for survivors of sexual violence, their families, and friends. Support groups, crisis intervention, informational guidance, and assistance in accessing community resources. Accompaniment to medical facilities, law enforcement, or court regardless of when the violence occurred. Community-wide awareness programs and preventive education covering sexual violence prevention, harassment, internet safety, and personal body safety across diverse age groups.

### **Children’s Advocacy Centers**

Located in Fort Fairfield and Marshfield, the centers serve to alleviate trauma and aid in the recovery of children and families impacted by allegations of sexual abuse by offering a secure, impartial, trauma informed environment that offers a streamlined, evidence-based community response, striving to enhance coordination among child abuse response agencies for more effective support. Referrals are made by DHHS, District Attorney’s Office, or law enforcement.



## PREVENTION

Youth prevention resources focused on school-age youth.

### Aroostook Teen Leadership Camp (ATLC)

Available in Aroostook County. Develops teen leaders who gain knowledge, skills, training, and support to work with other teens effectively through a five-day residential summer camp and school-based activities throughout the year. A focus on leadership skills, substance use awareness education, team building, and coping skills development. For more information, contact 207-493-3361.

### Downeast Prevention Specialist

Available in Hancock and Washington counties. Substance use prevention education to schools including Prime for Life, Botvin Life Skills, bullying prevention, bystander intervention, gender norms, media literacy, online safety, and cyber citizenship.

## COMMUNITY & FAMILY SUPPORT

AMHC serves adults with intellectual disabilities and individuals with traumatic brain injury. The agency also supports family relationships and reunification.

### Family Visitation

Facilitation of supervised and supportive visits with children (in DHHS custody) and their parents or designated individuals during the phases of reunification and rehabilitation. For more information contact 207-532-6523 (Aroostook) or 207-498-0289 (Hancock/Washington).

### Family Time Coaching

A 16-week evidence based relational model that supports facilitation between parent and child. Change can be promoted through enhanced parent/child interaction in partnership with a coach/clinical social worker.

### St. John Valley Associates (SJVA)

Available in Aroostook County. St. John Valley Associates (SJVA) is committed to empowering adults with intellectual disabilities, offering various daily living skills, including cooking, socializing, physical development, and computer skills. SJVA provides day programming and home support services. For more information, contact 207-728-7197.

### Center For Integrated Neuro Rehab (CINR)

Available in Aroostook County. Located in Caribou and Houlton, CINR provides comprehensive brain injury rehabilitation through a day treatment program specifically designed to address deficits that might hinder a brain injury survivor's optimal recovery, focusing on intellectual, emotional, and social functioning.
