In 2024, Aroostook Mental Health Services, Inc. (AMHC) proudly celebrated its 60th anniversary. Founded in 1964, the agency has become the largest behavioral healthcare provider in the region, with 27 service locations across Aroostook, Hancock, and Washington counties, serving individuals and families of all ages. The agency annually supports up to 5,500 outpatient and residential clientele, with a team of 350+ employees delivering a comprehensive range of services in mental health, substance use, crisis, sexual assault, prevention, brain injury, and programs for adults with developmental disabilities.

In 2021, AMHC was named a Certified Community Behavioral Health Clinic (CCBHC). Guided by the agency's mission to provide integrated healthcare services that maximize an individual's potential to recover and improve their quality of life, a CCBHC designation advances AMHC's commitment to provide a patient-centered approach, characterized by a high degree of collaboration among the community and health professionals and led by the client as the focal point of all services. No individual is denied access to services due to an inability to pay. A discounted/sliding fee schedule is available based on family size and income.

AMHC is a National Health Service Corps (NHSC) host organization supporting individuals interested in entering the behavioral health field with loan forgiveness programs and internship opportunities. A designated Recovery Friendly Workplace Employer, AMHC is dedicated to offering a healthy, safe, and stigma-free work environment to eliminate barriers to recovery for those impacted by addiction.


Highlights of our anniversary year included:

AMHC Mobile Crisis Response Expands Community Presence

Providers in Schools, Recovery Centers, and Law Enforcement Agencies

With the State of Maine contracting with AMHC for 24/7 mobile crisis response in Aroostook, Hancock, and Washington counties, AMHC expanded its reach by embedding crisis providers in community settings. "AMHC crisis providers support individuals in behavioral health crises through in-person, telehealth, phone, or chat," says Sarah Wright, Program Director of Crisis Services. This year, AMHC piloted embedded programs at schools, recovery centers, and the Presque Isle Police Department (PIPD). Starting in May, a crisis provider is stationed daily at PIPD from 10 am – 10 pm, joining officers on calls involving potential behavioral health crises. PIPD Chief Chris Hayes noted, "Having someone out of uniform can help ease fears." Other departments throughout the state are considering similar partnerships.

SAS Reaches Milestone 40th Anniversary of Support

Together for Healing and Justice: Thank You to Our Sponsors

In 2024, AMHC Sexual Assault Services (SAS) proudly celebrated its 40th anniversary, having started serving clients in 1984. Today, the program continues to offer a wide range of services, all at no charge-ensuring that there are no hidden fees and no costs to the individual or their insurance. SAS provides a 24/7 helpline for victims, survivors, and affected others and accompanies medical appointments, court hearings, and law enforcement proceedings. Additionally, the program provides prevention education and community awareness initiatives upon request, focusing on local schools, health fairs, and businesses. For children who have been allegedly sexually assaulted, the Aroostook and Downeast Children's

Advocacy Centers offer a trauma-informed, evidence-based, multi-disciplinary setting where they can undergo a forensic interview that is admissible in court.

To celebrate this milestone, AMHC SAS hosted an 80s-themed Dance Party during Sexual Assault Awareness Month in April. We are grateful to the local businesses that contributed nearly \$7,500 to support this event.

The mission of AMHC Sexual Assault Services is to promote healing and justice for all who are affected by sexual violence through advocacy, education, and prevention, and we could not fulfill this mission without the generous support of our community partners. Thank you!

AMHC Expands Residential Treatment Facility in Presque Isle

AMHC's Commitment to Recovery Grows with New Location



AMHC held an open house for its new Residential Treatment Facility (RTF) on December 1, 2023. The move from Limestone to Presque Isle enabled the RTF to expand from 12 to 18 beds and introduce enhanced services, including withdrawal management, improved nursing, care coordination, and discharge support. Senator Susan Collins and Gordon Smith, State of Maine Director of Opioid Response, were guest speakers. Senator Collins shared: "AMHC has led the charge to empower those seeking treatment and recovery from substance use disorder in northern Maine for nearly sixty years," said Senator Collins. "It was a pleasure to join them in the dedication of this wonderful new facility, which will allow them to meet the rising demand for their important services. As Vice Chair of the Appropriations Committee, I am committed to ensuring that the needs of Maine's people are met. Access to treatment is essential if we are to break the cycle of addiction."

This project was made possible with a \$1,000,000 award through the 2022 Congressionally Delegated Services funding request supported by Senator Susan Collins, a \$600,000 award through the State of Maine Department of Health and Human Services, which contributed 34% of the funding, and a \$150,000 allocation from an award through the Health Resources Services Administration Rural Communities Opioid Response Program*.

AMHC Unites Services at New Ellsworth Location

Centralized Site Improves Access to Comprehensive Services



In December 2023, the Ellsworth Outpatient Office and Downeast Treatment Center combined services into one location at 70 Kingsland Crossing in Ellsworth. "We are pleased to offer AMHC services from a central location," said Ellen Bemis, CEO. "We are closer to city amenities, including other healthcare providers, retail stores, and more. In addition, by placing the Downeast Treatment Facility

and outpatient office under one roof, we make it easier for our clients to access a full range of behavioral health services, with an opportunity to expand and grow programming."

AMHC has been offering mental health, substance use, crisis, and sexual assault services in Hancock County since 2009. Thanks to a partnership with Downeast Treatment Substance Network (DSTN), a partnership of organizations and community members in Downeast, Maine, the Downeast Treatment Center opened in 2018, providing a "hub and spoke" model of care for individuals with substance use disorder. A community open house and ribbon cutting were held on April 30, 2024, and included tours, program education, and refreshments.

AMHC Grant Supports Health Navigator in Schools

Improving Access and Connecting Families with Essential Care

The HRSA Behavioral Health Support grant from AMHC in 2022 allowed Jenn Libby to be hired as a school-based community health navigator at the Jonesport-Beals school system. As a trained public health worker, Jenn is a bridge between providers and individuals to promote health, reduce disparities, improve service delivery, and advocate for individual and community needs. She is responsible for promoting AMHC and other services by connecting clients and their families to tele-behavioral health and linking students and their families with other needed services. She collaborates closely with care coordinators and clinical support staff to ensure that students have access to services provided by the agency. Since her hire, Jenn has supported 53 students with 557 in-person and/or tele-behavioral health appointments. "Being a School-Based Community Health Navigator is more than just being another body in the building," explains Jenn. "It's about being the bridge to help fill the gap for families and services. It's about being an advocate for what students and their families need. It's about being a part of a community."



HRSA Grants Provide Education and Training to 300+

Participants Gain Valuable Skills in Behavioral Health and Prevention

More than 300 individuals participated in the following opportunities made available through HRSA RCORP Implementation III and Behavioral Health Support grants*:

- Since its launch in September 2023, Share Facts Save Lives (SFSL) has reached thousands through its website and social media channels about substance use disorder. Material is accessed through ShareFactsSaveLives.org.
- Thirteen individuals received stipends while interning at AMHC. Internships in behavioral health are traditionally unpaid positions, creating financial barriers and reducing the potential number of students who select this field.
- In partnership with the University of Vermont Center on Rural Addiction, 23 providers from the Mi'kmaq Health Center participated in "Identifying Bias and Addressing Stigma in a Clinical Setting" by Peter Jackson, MD.
- Forty AMHC providers and staff members attended a retreat day (see page 6 of the report).
- Thirty-six Aroostook County youth and adult leaders participated in SUD Prevention/Resiliency trainings at Aroostook Teen Leadership Camp.
- ✓ During the 2023/2024 school year, AMHC's Prevention Specialist provided 115 Hancock and Washington County high school students with evidenced-based Prime For Life and Botvin trainings.
- Nearly 200 providers from AMHC and Mi'kmaq Health Center participated in a tribal cultural competency training by John J. Dennis, MSLing, BEdu, a member of the Mi'kmaq Tribe.
- Three AMHC staff members received Advanced Motivational Interviewing training, and nine received Eye Movement Desensitization Reprocessing (EMDR) training.

"This achievement is testimony to the consistent, highquality service CINR staff has maintained since opening in 2007," said Christine Brown, Program Director of Community Integration.

Bozzo's visit strengthened these connections and highlighted their collaborative efforts to enhance mental health services in Maine.



ATLC Empowers Youth with Leadership and Substance-Free Living Tools

Nearly 40 campers and student staff members attended ATLC at the University of Maine Fort Kent. The camp once again hosted national presenters Ed Gerety, Matt Bellace, and Harriet Turk. All three presented the value of living substance-free and offered realistic tools to stay focused on sobriety and being leaders in one's community. Former State Representative/State Senator Justin Chenette also presented on "leadership at any age" through service to one's community. In addition, various local leaders presented workshops on several topics of interest to youth.

As part of ATLC's fundraising efforts, a music concert featuring Star City Syndicate was held at the Caribou Performing Arts Center in January. The event was organized by Doug Cronkite, a long-time ATLC volunteer and lead singer for the band. The venue costs were covered thanks to generous sponsorships from Gil's Sanitation and the Washburn Rotary Club. Additionally, the Rotary Club hosted a 50/50 cash raffle at the event, donating their portion to ATLC. The concert raised a total of \$4,000 for the cause.

ATLC is only possible with the generosity of its major funding sources. In addition to Star City Syndicate, other major funders include Maine Youth Action Network, Health Resources Services Administration (HRSA) Rural Community Opioid Response Program Implementation III grant, HRSA Behavioral Health Support grant, Harold Alfond Foundation, 1st District Masters & Wardens Association, Center Transportation, Center Farms, Garfield Royal ARCH Chapter #48, County Federal Credit Union, MMG Insurance, Jefferson Cary Foundation, and Presque Isle Rotary. Another two dozen organizations and businesses provided monetary and in-kind donations. All funds raised focus on positively promoting youth to inspire leadership potential and substance-free living.

Calais Facility Expansion Secures \$4.3 Million in Federal Support

AMHC has received approval for a \$4.3 million Congressionally Delegated Spending (CDS) appropriation, with support from Maine Senators Susan Collins and Angus King. This funding will support an expansion of the Calais facility, helping to enhance treatment outcomes for both adults and children in the Calais residential and crisis stabilization units. The funds will also improve the heating and cooling systems and replace the parking lot. Construction is scheduled to begin in Spring 2025, with completion expected by the end of the year.

AMHC Launches New Website to Enhance Service Access

In August 2024, AMHC proudly launched its newly redesigned website, AMHC.org. Featuring a modern, user-friendly design, the site offers improved navigation and valuable information about AMHC's mission and services. Key updates include mobile optimization, detailed service descriptions, downloadable resources, and easy access to helplines.

Partnership with Opiate Free Island Partnership Brings Awareness to SUD

In partnership with Opiate Free Island Partnership, last October, AMHC supported 120 students from the Stonington and Deer Isle schools with a local viewing of Jacinta, a documentary that follows the recovery of a family in which the mother and daughter both have a substance use disorder and spent time at the Maine Correctional Center. Sixty percent of the student body identified someone in their household had or is in recovery with a substance use disorder.

AMHC Secures \$4 Million Grant to Expand Behavioral Health Services



AMHC has been awarded a four-year, \$4 million Certified Community Behavioral Health Clinic (CCBHC) Improvement and Advancement (IA) Grant from the Substance Abuse and Mental Health Services Administration (SAMHSA). Starting on April 30, 2024, this funding builds on AMHC's previous CCBHC grant and will help expand and improve services, particularly for underserved populations.

A key focus of the grant is the addition of new care coordination positions, including a specialist for veterans. This funding will enable AMHC to continue providing a wide range of essential services directly and through partnerships. These services include crisis support, screening, diagnosis, risk assessments, psychiatric rehabilitation, and outpatient primary care screenings. The grant will also enhance targeted care management, peer and family support, counselor services, and community-based mental health care for veterans. Additionally, it will support individualized treatment planning for clients and their families and ongoing outpatient mental health and substance use services. With this support, AMHC will be better equipped to provide comprehensive, accessible behavioral health care, ensuring more individuals can access the necessary resources.









